\_\_\_\_\_ Tools and Equipment costs are not covered by the PSEO program and must be purchased by the student to participate in the program. There is no funding assistance for these costs to the student.

\_\_\_\_\_ Certain programs require summer course work. These courses, tuition, fees, and books are not covered by the PSEO program and the charges must be paid in full on the semester start date by the student.

\_\_\_\_\_ Because placement into a high demand program for PSEO is not guaranteed, the student should also complete a traditional application to start program after graduation from high school at the same time they submit their PSEO application.
